 The Law Review Subcommittee voted to carve out language that would allow for the term "advanced" to be used by those individuals who are licensed, "advanced estheticians" but would prohibit the term "advanced" from being used by licensees in other branches of cosmetology where there is no "advanced" license.

 The Law Review Subcommittee also moved to table a discussion on other qualifying terms, specifically "master" with regard to other branches of cosmetology.

The Board clarified that while the state of emergency is still in place, schools are allowed to do theory hours via distance education. Once the state of emergency has been lifted by the Governor, schools are to resume 100%, in- person theory training.

While the Board has discussed putting a cap on the maximum number of the total theory hours that can be completed via distance education during the state of emergency a vote was never taken on the matter.
