Limited License: Acknowledgement of Policies & Responsibilities

Pursuant to NRS 644A.455, a Limited License is valid for 12 months and permits the holder to perform services for no more than five periods, of not more than 10 days each, during those 12 months. The holder of a limited license is authorized to perform *limited services* on clients outside of a licensed salon. Listed below are the *limited services* that can lawfully be performed under your limited license:

If you are an Esthetician, you will only be able to provide the following services:

- Application of makeup to the skin and application of false eyelashes.

If you are a Cosmetologist, you will only be able to provide the following services:

- Tension on the hair stands such as twisting, wrapping, weaving, extending, locking, or braiding on the hair;
- Nonpermanent manipulation of the hair such as styling, wrapping, arranging, braiding, twisting, weaving, extending, fusing, dressing, curling, setting, or straightening;
- Application of makeup to the skin and application of false eyelashes.;
- Removal of existing nail polish from and application of nail polish to the nails.

If you are a Hair Designer, you will only be able to provide the following services:

- Tension on the hair stands such as twisting, wrapping, weaving, extending, locking, or braiding of the hair;
- Nonpermanent manipulation of the hair such as styling, wrapping, arranging, braiding, twisting, weaving, extending, fusing, dressing, curling, setting, or straightening.

If you are a Nail Technologist, you will only be able to provide the following services:

- Removal of existing nail polish from and application of nail polish to the nails.

_____ I understand that I must notify the Board in writing of limited license services five or more days before the service is performed. The notice can be sent via email to inspection@nvcosmo.com. (NRS 644A.455(7))

_____ I understand that the notice must include the licensee's name and Limited License number, Date and time of appointment, name, and address of the location where you will be providing these services NRS 644A.455 (7)

_____ I understand that the name of the client and the address at which services are performed in an appointment book or system must remain at the cosmetological establishment or permanent place of business and be made available upon request to any investigator or inspector of the Board (NAC 644A.825 (3))

_____ I understand the scope of practice for a limited license. NAC 644A.825(b)

_____ I understand that I must list my Limited License number on all of the advertisements. (NRS 644A.800)

_____ I understand that failure to comply with these regulations will result in a citation of \$500.00 for the first offense, \$1000 for the second offense, and \$1,500 for the third offense.
