Some examples of these proposed bills are Assembly Bill 371 which enacts the Cosmetology Licensure Compact or Assembly Bill 225 which revises provisions to licensing of certain professions and occupations just to name a few. These are exciting times for the cosmetology industry, so we encourage our industry to please stay informed, active, and participate.

## **Student and Instructor Communication Student Information**

If you request your hours from your school, under NAC 644A.620, the school has up to 10 business days to provide you with the documentation. Once you complete or withdraw, the school has 15 days to notify the board.

According to NAC 644A.618, any work performed by a student MUST be provided under the supervision of a licensed instructor. This means you cannot work from home.

#### **Instructor Information**

Are you demonstrating best practices for sanitation standards? NAC 644A.740 Disinfectant; instruments, implements and other tools; sterilization equipment; disposable articles; singleuse items can be used to educate students about state requirements.





#### **School Information**

Remember to enroll students into the portal within 30 days of the student starting! The law and regulation require the board to be notified within 30 days. It is now a citable offense if students are not enrolled within the correct timeframe.

The board must be notified within 15 days of a student's completion or withdrawal. Make sure you are completing and withdrawing students within the timeframe.

Are students paying for services? NAC644A.644 Prohibition against requiring students to purchase supplies for the use in course of study. Please be sure to review school policies to ensure your school is in compliance.

#### **Licensee Communication**

If you renew your license and want to pick it up, contact the Board beforehand, so it does not get mailed out!

Moving? Update your address to stay current on your license and any communication from the Board! NRS 644A.510 Notice to Board of change of place of business or personal mailing address says you need to update your information within 30 days of moving.

Is your license displayed at your work station in plan view of the public? NRS 644A.530 Display of license or certificate of registration states your current license must displayed. Your license must be displayed at your workstation or where services are performed in plain view to the public. This is a \$200 citable first offense.

Citations must be paid within 30 days. If the citations are not paid within 30 days, they will be sent to collections.



#### **Establishment Information**

According to NRS 644A.605, any changes of ownership, establishment name, services offered (removed or added), or location must be accompanied by a new application. Salon licenses are NOT transferrable. Operating without a license is a \$1000 first-offense citation.

Any citations received must be paid within 30 days. If the citations are not paid within 30 days, they will be sent to collections.

Under NAC 644A.520 Inspection of establishment by Board; refusal to grant access constitutes grounds for disciplinary action; inspections are conducted during normal business hours. If your establishment has a code to be let in, please contact the Board staff to avoid any compliance reviews or citations.

Did you know...
Law books are available for purchase. NRS and NAC can be viewed online; however, the law books will be revised by the revised pates. Attorney General onlines and an NRS include additional information. They will include the revisor's notes, Attorney General opinions, and an NRS cross-reference.

Are you currently using roll-on wax? Did you know the wax cartridges are single-use? Changing the roller heads only does not meet the sanitation requirements, as the unused wax from the roller goes back into the cartridge. NAC 644A.740 Disinfectants; instruments, implements and other tools; sterilization equipment; disposable articles; single-use items say that single-use items must not be used on more than one client.

Are you not sure if a person is licensed? You can verify on our website. Go to https://www.nvcosmo.com/licensee-lookup You can also verify licensed establishments on our website.

Top 3 violations issued by the Compliance Department are:

- 1. Failing to apply infection prevention procedures on instruments, implements, and other tools {sanitation and disinfection process). (Soiled implements or improper use of disinfectant)
- 2. Failing to maintain equipment, walls, floors, etc. (Equipment not kept clean, like towel warmers, wax pots, sterilizers, etc.)
- 3. Failing to maintain cosmetics and preparations (Not properly storing implements in closed containers and contaminated wax/paraffin)
