 - ***Outstanding Citation Violations:*** The Respondent shall pay all outstanding violations, totaling \$5,000
 - ***Administrative Fine:*** The Respondent shall pay an administrative fine of \$2,000
 - ***Payment of Total Monies Owed:*** The Respondent agrees to pay the total sum of \$18,000 within 90 days of executing the Settlement Order.
