A. Roll Call

The Board meeting was called to order by Vice Chair Baltazar at 9:00AM PST.

B. Mission Statement

The mission of the Nevada State Board of Cosmetology is to protect the public health, safety and welfare of those that obtain cosmetology related services through the delivery of quality Testing, Licensing, Inspection and Education Services that focus on consumer protection.

D. Subcommittee Law Review

 Approval of minutes from law review subcommittee meeting on December 7, 2020- for discussion and possible action

The minutes from the law review subcommittee meeting on December 7, 2020 were approved.

2. Review of hair braiding licensing requirements and hair braider scopes of practice in neighboring states-for discussion

The law review subcommittee will review the scopes of practice and licensing requirements for hair braiders and natural hair artists in Nevada's neighboring states.

The law review subcommittee reviewed information on hair braiding licensing laws and scopes of practice for hair braiders in Nevada's neighboring states. No vote was taken on the matter.

3. Review of shampoo technology licensing requirements and scopes of practice in neighboring statesfor discussion

The law review subcommittee will review the scopes of practice and licensing requirements for shampoo technologists in Nevada's neighboring states.

The law review subcommittee viewed data on licensed shampoo technologists in Nevada as well as shampoo technology data in other states. No vote was taken on the matter.

4. The subcommittee is to review the following provision(s) of Chapter 644A of the Nevada Revised Statutes to then make recommendations, if any, to the full Nevada State Board of Cosmetology at a future open meeting-for discussion and possible action

NRS 644A.085-"Hair braiding" defined

The law review subcommittee reviewed NRS 644A.085, hair braiding defined, and discussed whether to remove "cleansing" from the definition of hair braiding. The subcommittee asked that Deputy Director Higginbotham send a survey to the licensed hair braiders in Nevada asking whether shampooing and blow drying are necessary elements of their practice. No vote was taken on the matter, the discussion was tabled until a later law review subcommittee meeting when the results of the survey may be discussed.

5. Subcommittee to begin developing and drafting proposed tiered esthetics license system to be presented to the full Board-for discussion and possible action

The law review subcommittee will begin developing and drafting language to reflect a tiered (basic and advanced) esthetics licensing system in Nevada. The proposed language will be brought before the full board of cosmetology for review and possible approval at an upcoming meeting.

The law review subcommittee directed staff to being working on drafting of the laws/regulations that would allow for an advanced esthetic license in Nevada. The law review subcommittee asked that Director Landry to reach out to the medical and nursing boards as well as the health depart to see what impact, if any, an advanced license would have on their industries.
