Student and Instructor Communication

Student information

Pursuant to NAC 644A.618 students can only provide services at their school under the supervision of a licensed instructor. The NSBOC advises students to avoid phrases like "DM me to book" or any other scheduling outside of the school on their social media accounts.

Licensee Communication

Start off the new year right by keeping your stations in compliance and throwing away single-use items. Pursuant to NAC 644A.730, all single-use items, including but not limited to, neck strips, nail files, and buffers that come into contact with a client must be disposed of immediately after use. This means you cannot reuse single use items or store them.

There is a list of prohibited procedures pursuant to NAC 644A.790 that licensees are not able to perform or have on the premises. These invasive procedures include but are not limited to the application of a topical lotion, cream or other substance which is not intended for use by a practitioner of a branch of cosmetology for the purpose of beautifying the skin or which affects anything below the stratum corneum. You are not able to remove a callus using an instrument, tool, or other device that has a sharp edge, blade, or point. You are not able to perform an injection or administration of any substance, including, without limitation, a controlled substance. You are not able to perform any ablative services.

School Communication.

Pursuant to NRS 644A.740/NAC 644A.642, students can attend no more than 40 hours a week and no more than 10 hours per day. If a student is making up hours, they can complete no more than additional make up 10 hours.

If the school is offering the advanced esthetic program, pursuant to NAC 644A.6395, the medical professional must visit the school quarterly. Make sure all paperwork is up to date and accurate.

Is your school demonstrating best practice for sanitation standards? NAC 644A.740 Disinfectants; instruments, implements and other tools; sterilization equipment; disposable articles; single-use items can be used to educate students of state requirements.



Establishment Communication

Pursuant to NRS 644A.940 it is unlawful for an animal to be on the premises of a licensed cosmetologically establishment unless it is a service animal. Questions you may ask are: Is the dog a service animal required because of a disability?

What work or task has the dog been trained to perform?

Every cosmetological establishment must have a permanently plumbed sink with hot and cold running water at all times. The sinks need to be located where work is performed and supplies are dispensed per NAC 644A.725.
